**English Essay** 50 Urdu Essav 50 Subjective Pakistan Penal Code, 1860, 8 Objective 100 Order, 1984 and Anti-Rape (Investigation and Trial) Act, 2021 (MCQs) Viva Voce + Psychological Assessment

The Commission may conduct the written examinations in two phases to shortlist the candidates": PHASES: Phase-I: All candidates will be called for Written Test in MCQs Paper-3

Phase-II: The candidates who obtained 40% marks (40 out of 100) in Paper-3 i.e. MCQs paper will be called for Phase-II/Paper-1 & 2 i.e. English Essay (Paper-I) and Urdu Essay (Paper-2). NOTE:

i) Negative Marking will be done and 0.25 marks will be deducted for each wrong answer in the MCQ type paper. i) The candidate must obtain 40% marks in each paper and 50% marks in the aggregate to qualify. The qualified candidates will be called for viva voce at the ratio of 1:5 with respect to number of posts. They may also be

called for Psychological Assessment.

Candidates are required to mention Physical Standard in their Online Application Form as per Certificate of Physical Standard issued by the Medical Superintendent of District Headquarters Hospitals or Service Hospital, Lahore or Police Hospitals shall be accepted under the Regulations/Policy Decisions. However, Medical Fitness Certificate issued within three (03) months prior to the closing date of the Advertisement shall be acceptable subject to the condition that the candidate fulfills all other requirements of Physical Standards prescribed for the post. Medical Certificate issued after the closing date shall not be accepted.

**IMPORTANT NOTES** 

Tempering/overwriting in Medical Certificate shall not be accepted. Chest expansion less than 1.5 is not acceptable such if a candidate has unexpanded chest 38 and expanded chest 39, it will not meet with requirement of eligibility and to be rejected unless he possesses the chest standard as un-expanded 38 and expanded by 1 ½ will become 39 ½, resultantly he possessed expansion 1 ½ and will be held eligible with regard to chest standard as per advertisement/service rules. Medical Certificate issued from Govt. Tehsil. Hospital/Private Hospital will not be accepted at all.

Medical Certificate issued on OPD slip is not acceptable. Medical certificate issued only on the format of PPSC will be accepted which is available on PPSC official website (www.ppsc.gop.pk). A candidate shall have to obtain 40% marks in each paper and 50% marks in the aggregate i.e. 100 out of 200 to qualify for interview. Thereafter, a candidate shall also secure 50% marks in the interview i.e. 75 out of 150 to be held eligible for final merit list of successful candidates.

No relaxation in age (General age relaxation), education or physical standard shall be allowed. Punjab Civil Servants recruitment relaxation in upper age limit) Rules 1976 are not applicable in Police Department.

After recruitment no Inspector (Legal) shall be allowed to seek change of cadre from Inspector (Legal) to the executive or any other branch in the Police Department. The candidates who qualify in the examination and are recommended for appointment will have to appear for such medical examination and meet such conditions of appointment other than the above, as are prescribed by the Government.

Recruitment to the posts of Inspector Legal is governed by the Punjab Police Service Rules, 1934. The conditions of eligibility other than those mentioned above shall be regulated these Rules. Change in the priority/ selection of examination centers shall not be allowed.

Those candidates who are declared provisionally successful for interview may be called for psychological assessment before interview
