4. Only shortlisted candidates after qualifying the interview shall be called for driving test. The organization reserves the right to cancel advertised post or to accept/reject any application.
5. Employees serving in Government/Semi-Government departments must provide No Objection Certificate (NOC) at the time of interview.
6. Candidate shall be disqualified if false information is provided at any stage.
7. Selected candidate will undergo a 06 months' probation period, extendable subject to performance.
8. Selected candidate shall provide Medical Fitness and Character Certificates.
9. **Appointment is being made against a specific NADRA location; therefore, no request for transfer shall be entertained.**
10. Electronic gadgets such as mobile phone, smart watch etc. will not be allowed during test/interview.
